

The Children:

I will only access the system with my own username and password, which I will keep secret. I will not use other children's usernames or passwords.

I will only use the Internet when I have permission and am supervised.

I will only e-mail people my teacher has approved using my school e-mail account and I will only send photographs to people I know and trust.

I will not send unsuitable email messages; my messages will be polite, responsible and only signed in my name.

I will respect the privacy of others. I will not publish their names, addresses, phone numbers or photographs.

I will not give my personal details to anyone over the internet e.g. full name, home address, family information or telephone number.

I will not arrange to meet anyone contacted over the Internet.

I will not copy work directly from the Internet and pretend it is my work.

I will not try to find unacceptable material from the Internet.

Children continued:

I will always tell an adult straight away if I am upset or worried about something that has happened online. I will save any messages that have upset me so I can show them to who I tell as they will be able to help.

I will not be able to buy or sell anything over the Internet.

I will not download software from the Internet.

I will not bring in floppy discs, CDs, data sticks to school unless I have been given permission.

I understand that the school will check my files and will keep track of the Internet sites I visit.

I will not access social networking sites in which I have to lie about my age to register. E.g. Facebook – children must be 13 or older.

The Parents:

To help my child stay safe using the Internet, I will do my best to:

Monitor my child's use of the Internet outside school using any technology for example PSP, Wii, mobile phone, laptop and by adhering to our Acceptable Use Policy.

To use our learning platform safely and appropriately.

Discuss e-safety issues with my children, supporting the school in its e-safety approaches and reinforcing appropriate behaviour at home.

Liaise with school if they suspect or have identified that their child is conducting risky behaviour online.

Not allow my child to lie about their age and access social networking sites e.g. Facebook which are designed for older children and adults.
